V. Officer Reports

A. President: Several members of the Portage County Young Democrats participated in the Young Democrats of America Winter meeting on December 12th and 13th, 2020. During the region meeting opportunities were discussed for the Great Lakes region to support the Georgia Senate RunOff Elections; "I would encourage you all to participate."

As we move forward in the meeting tonight I would like to discuss the necessity of hosting a constitutional convention in January to address several inconsistencies across our organization's governing documents.

Tomorrow evening I will discuss in the Portage County Democratic Party's Central Meeting. Later this week I will participate in the Ohio Young Democrats winter conference.

- Available cash funds in the bank account are \$1,190.10.

PAC REPORTS

PreGen 2020 report was not filed at the correct time, due to a misunderstanding of thresholds. Upon notice of such, rectified situation by filing PreGen & PostGen reports on December 11.

Christopher went into BOE to advise; included a signed note explaining the situation. Advised that will be referred to the BOE Board for a hearing. Will need to appear in person or send a notified/certified letter. (Awaiting request to respond; will be sending certified response).

At the same time we provided an updated Des. of Treasurer - to update mailing addresses on file for both org and President.

D. Sergeant-At-Arms: In the process of verifying membership including age, paid status, and all requirements outlined in the constitution. Effective December 16, 2020 the following members have been certified as Voting for 2021: Christopher Clevenger-Morris, Matthew Cola, Ashton Narzisi.

I'm drafting for the proposed Constitutional Convention language to state that unless they are running, SAA serves as elections officer (Article VI, Section IV). I will be completing another full review of the constitution and bylaws and standing rules prior to that meeting.

Emergency Orders

PRESIDENT: Pursuant to the Portage County Young Democrats Standing Rules, I do hereby submit to you the following proposed suspension of the governing documents due to emergency declaration:

In reference to the Portage County Constitution and Bylaws, I do hereby propose that the Emergency Orders clause be activated to allow for electronic meetings as they affect Article VI: Elections, Article X: Meetings, and Article XIV: Amendments for business to be conducted in January of 2021.

NOTE: This submission will be provided electronically to each Elected Officer, who must respond within 24 hours.

Constitutional Convention (If Necessary)

PRESIDENT: Upon a full review of the governing documents, and following consultation with several officers and members of the organization, I have deemed a constitutional convention of the organization necessary. As such I am proposing the date of January 11, 2021 at 6:30 PM EST.

Motion: To hold a constitutional convention for the Governing Documents of the Portage County Young Democrats on Monday, January 11, 2021 at 6:30 PM EST.

Moved: Narzisi Second: Cola Motion: Carries **PRESIDENT:** All proposed changes to the constitution and bylaws should be proposed in writing to the President no later than December 26, 2020. Proposed Changes will be posted on our website under the meeting notice to allow for members to review them.

Endorsement Process Review

TREASURER: I would like to send a followup packet/package to the endorsed to ask the following: What worked for you and what didn't? What was helpful? What could we have done better?

SERGEANT AT ARMS: "As an organization we are consistently trying to improve our endorsements process; as such we are seeking your input to guide considerations as our process evolves."

TREASURER: I still stand by the endorsement process being necessary - in that you must participate to receive action on behalf of the organization. I would like to establish a timeline on this as to when we will get it out so we have time to get the feedback and necessary changes implemented before the May Primary Election and the endorsement process surrounding that election.

PRESIDENT: I would like to consider amending the Standing Rules this evening to include proposed changes to add an Endorsement Length and Revocation Section.

Motion: To add to the Standing Rules under Article 6, Section 05, the following text.

Moved: Cola Second: Narzisi Motion: Carries

ADD NEW SECTION: Endorsement Length and Revocation.

1. Endorsements of the Portage County Young Democrats will be considered active through the certification of general election results by the Board of Elections, and/or Secretary of State.

A. Should a candidate for office be unsuccessful in their primary election, or withdraw from said election, their endorsement will be considered null and void upon certification of the Board of Elections, and/or Secretary of State.

2. If the Campaign Committee has not yet formed to consider endorsement in an election cycle, the Executive Committee may vote to allow specific actions

supporting previously elected and endorsed candidates seeking re-election to the same office.

3. The Executive Committee of the Portage County Young Democrats may vote to revoke the endorsement of a candidate, issue or referendum at any time.

- A. Violations of local, state and/or federal law, of the governing documents of this organization or affiliated organizations, or actions that directly contradict the mission and/or vision of the Portage County Young Democrats may be considered grounds for endorsement revocation.
- B. A 2/3 majority vote of the Executive Committee is required to revoke the endorsement of a candidate, issue or referendum.
- C. In the event of a revocation of endorsement for a candidate in an election, a joint session of the Executive Committee and Campaigns Committee may be called within seven (7) days to consider the endorsement of another candidate.
 - a. Such endorsement would require a 2/3 majority vote of voting committee members present.
 - b. Only voting members of the Executive Committee and Campaigns Committee will be permitted to speak.
 - c. In the case of a Democratic primary, other Democrats appearing on the ballot may be considered.
 - d. In the case of a nonpartisan election, all other candidates for the same office may be considered.

Line of Succession (gender)

Motion: To approve the addition of the following text to the Standing Rules to formally establish the line of succession of the Portage County Young Democrats, per the established DNC Gender Parity guidance. Moved: Cola Second: Narzisi Motion: Carried

LINE OF SUCCESSION

I. In the event of the absence and/or incapacity of the Presiding Officer of this Organization (President), or upon their demise, the following line of succession shall

govern the organization:

- 1. Treasurer
- 2. Vice President
- 3. Secretary
- 4. Sergeant At Arms

Pursuant to Article III of the Charter and Bylaws of the Democratic Party of the United States, this organization will endeavor to ensure that the President and next Highest Ranking officer of the Portage County Young Democrats will not share the same gender identity.
